<u>Public access to the meeting</u> - members of the public have a right to attend any meeting of the Council, its Committees (or Sub-Committees, if any) held in public or that part of the proceedings which are held in public and have access to any public report or other public papers

<u>Public Questions or Statements</u> - members of the public have a right to ask questions or make statements relating to the business of that body subject to conditions: -

- a) Members of the public are able to ask questions or make statements, at this point on the agenda, on matters which are not otherwise on the agenda for the meeting.
- b) The overall time limit for public statements or questions will be 30 minutes, but no single member of the public will be entitled to speak for more than 3 minutes.
